

2010 PRESQUE ISLE YACHT CLUB HOUSE & GROUND RULES

BREAKING THESE RULES OR ANY OTHER POSTED RULES MAY BE CAUSE FOR MEMBERSHIP LOSS AS OUTLINED IN ARTICLES VII AND X OF THE PRESQUE ISLE YACHT CLUB CONSTITUTION

1. Children are not allowed free access to the clubhouse, and are not to run around, and must be under the supervision of an adult whenever they are in the clubhouse.
 2. Dogs or pets are not allowed in the clubhouse or picnic shelter at any time. Dogs must remain on a leash or on board and be under control at all times
 3. Those using the clubhouse or galley and its facilities are required to clean up immediately after use.
 4. Galley and picnic shelter refrigerators use is limited to overnight use and must be kept clean and free from spoiling food. Storage of personal items is at your own risk. Galley rules must be observed.
 5. No club equipment – dishes, cooking utensils, tables, chairs, etc. - are to be removed from the club or grounds.
 6. Garbage and rubbish are not to be left in the clubhouse or picnic shelter. All must be taken to outside containers and to be disposed of in provided containers, cardboard boxes are to be broken down before disposal.
 7. Club foodstuff is not for personal use.
 8. The restrooms are to be kept clean by the users including showers and hand basins.
 9. Entrance doors are to be kept locked at all times unless otherwise designated by the House and Grounds Chairman.
 10. Members are not allowed to entertain more than 10 guests at any one time, unless the Rear Commodore grants permission.
 11. From November 1 to May 1 members may be granted use of the clubhouse for special family occasions, which shall be limited to 96 persons.
 - a. A minimum of \$150.00 will be charged with all responsibility and clean up assumed by the user. \$75.00 to be returned upon inspection of clubhouse by the Rear Commodore.
 - b. Use may also be granted for non-family occasions by the Rear commodore after discussion with other command officers. A minimum of \$225 will be charged with all responsibility and clean up assumed by the user, \$75.00 to be returned upon inspection of clubhouse by the Rear Commodore.
 - c. All arrangements must be made in advance with the Rear Commodore. Other dates and exceptions for “not for profit” boating organizations will be available at board’s discretion.
 12. Smoking is not permitted in any portion of the clubhouse or picnic shelter. All cigarette and cigar butts shall be placed in suitable refuse containers.
 13. Camping and house trailers, motor homes, campers or such are prohibited on club grounds, without prior permission and fees to be determined by the Rear Commodore.
 14. Dogs must be walked in the designated dog walk area. This is the fenced in area near D-Dock and is marked as such. Dog owners are responsible to clean up after their pet. Dogs may be off leash in this area as long as they remain under supervised control and do not impede others.
 15. Personal Picnic Tables must be approved by the Rear commodore.
 16. Use of any club equipment is at the member’s risk.
 17. With the exception of official club functions, the period from 11:00 PM to 7:00 PM is **silent time**. This being a family-oriented organization, language and music containing what is generally considered offensive language, will not be tolerated.
